**CALL FOR PAPERS**

Between September 19 and 21, 2018, the 51st International Conference on Public Finance will be held at the Faculty of Economic Sciences of the National University of Córdoba. During the event lectures will be held by renowned experts in public sector economics, and special sessions will be held to present papers on issues related to public finances, especially the following, chosen as references for this edition:

- Fiscal Sustainability and Financing
- New Intergovernmental Fiscal Agreements
- Current Status and Trends in Pension Systems
- Functions and Financing of Local Governments
- Tax Evasion and Corruption: Causes and Consequences
- Experimental Methods in Public Economics

Those interested in submitting works, may submit their abstracts (or completed works) before May 28, 2018. This summary (no more than 5 pages) or complete work must necessarily include: title, three keywords, JEL classification, name complete of the authors, entity they represent, postal address, email address, fax and telephone number.

It is especially recommended to clearly state the objectives, methodology, sources of statistical information, bibliography, background or references to previous work, proposals or conclusions to which it is estimated to arrive.

- Edition: A4 page, single-spaced text, one column, justified, Arial 11 font, all margins of 2.5 cm
